TEGO® Glide B 1484

Food Contact Information

Food Contact legislation pertains to the end product, such as food packaging and kitchen utensils. While information on raw materials can aid in compliance, ultimate legal adherence can only be confirmed upon completion of the finished product. The following conformities are contingent upon the product being utilized in accordance with technical data sheet specifications, such as its use as an additive or co-binder, and at the designated usage level.

EU: Regulation 10/2011

TEGO® Glide B 1484 is in compliance with PIM up to an additive concentration of 400 mg/m² Food contact area. The product contains substance A (0,2%) and substance B (0,1%): both components are PPAs which need not to be listed in the positive list. A risk assessment has been conducted giving clearance up 400 mg/m². No further SML apply.

Germany: BfR Recommendations

Switzerland: SR 817.023.21 (Amended on 8. Dec. 2023; in force since 1. Feb. 2024)

TEGO® Glide B 1484 may be used for the manufacturing of printing inks for packaging according to Swiss Ordinance 817.023.21. The main components are either listed in ANNEX 10 or 2 without SML. The product also contains a non-listed, non CMR substance with a generic migration limit of 0.01 mg/kg Food.

German Ink Ordinance (GIO) / Consumer Goods Regulation (BedGgstV)

TEGO® Glide B 1484 may be used for the manufacturing of printing inks for packaging not intended for direct contact with food as defined in German BedGgstV. Migration of single components must not exceed 10 µg/kg food.

China: GB 9685–2016

TEGO® Glide B 1484 with respect to its active polymer composition is in compliance with GB 9685–2016 to be used in paint and coating for food contact only.

The product does not contain substances for which Specific Migration Limits (SML) and/or Restrictions / Specifications apply.

However, the product contains residues of processing aids which were risk assessed. The risk assessment was conducted at a worst case concentration of 400 mg Additive per square meter Food Contact surface.

We consider the product as safe to be used in food contact material for paint and coating application.

Japan: Japanese Positive List (PL) for Direct Food Contact

The Japanese positive list of substances used in synthetic resins for utensils, containers and packaging (UCP) in accordance with the implementation of the amended Food Sanitation Act came into force *on 1 June 2020. Since then*, Japan's Ministry of Health, Labour and Welfare (MHLW) published several draft versions of revised and restructured lists and continues to amend the lists and provisions during the granted five-year grace period. Therefore, the status of our products varies with the activities of MHLW and cannot be confirmed finally. Please, do not hesitate to ask for a temporary status in urgent cases.

USA: FDA

TEGO® Glide B 1484 can be used in compliance with the following section(s) and may be subject to any applicable limitations:

FDA 21 CFR 175.300

If used as a defoamer, the product is also compliant with Title 21 CFR 175.105.

TEGO® Glide B 1484 may be used in compliance with 21 CFR 176.170 and 176.180, if used as an additive at the wet end of the paper production and not to exceed 0.25kg/ton in the finished formulation.

Mercosur:

TEGO® Glide B 1484 is in compliance with MERCOSUR/GMC/RES. N° 39/19 MERCOSUR Technical Regulation on the Positive List of Additives for Plastics Materials and MERCOSUR/GMC/RES.N° 02/12: For the Polymerization Aids a risk assessment (acc. to point 4.4.b MERCOSUR/GMC/RES. N° 39/19) has been conducted giving clearance up 400 mg/m².
