PROCESSING

- · Add acrylates copolymer to the water while stirring
- · Add phase 2 while stirring
- \bullet Neutralize with sodium hydroxide to pH 6.5 and let under gentle stirring for futher 10 minutes
- Add all ingredients of phase 4, 5 and 6 while gentile stirring
- Check pH and if necessary adjust to 6.0-6.5 to improve transparency

Note: All formulations have been subjected to stability tests and have been shown to perform well. However, formulators should always perform their own stability tests when adapting formulations and / or using raw materials from other sources.
