PhytriCare™ IM is a blend of natural herbs and grape processing by-products to be used as palatability enhancer in feed for ruminant, swine and poultry.

PROCESSING

PhytriCare™ IM can be applied in ruminant, swine and poultry feed. The product is to be added into compound feed.

DIRECTION OF USE

Add the minimum recommended dosage as listed below to the animal's feed.

Ruminants	10	50	g per day per animal

A supplementation or distribution rate above the minimum recommended dosage can be done according to the animal age, the production stage and the farming condition.

INGREDIENT

The product is a blend of different flavonoid rich plant materials and herbal extracts. PhytriCare™ IM consists of compounds derived from grapes (*Vitis vinifera*), hops (*Humulus lupulus*), green tea (*Camelia sinensis*) and rosemary (*Salvia Rosmarinus*). It contains a maximum of 21% crude fiber.

STORAGE AND STABILITY

The product should be stored in a dark and dry place at room temperature in the original sealed packaging. PhytriCare™ IM is stable in its original packaging for at least 18 months under the recommended storage conditions.

PACKAGING

This product is available in 25 kg AluPE bags.

PRODUCT SPECIFICATION

PhytriCare™ IM contains plant materials with a high flavonoid content. These ingredients cover several different flavonoid subclasses which contribute to form a product specific Near-Infrared (NIR) profile. It contains a maximum of 21% crude fiber.
