ACCUREL® PPA 2110 can be applied in various film and extrusion processes, e.g. cast film, blown film, fibre, pipe and others. The additive is suitable for transparent as well as matt film applications.

ACCUREL® PPA 2110 is a PFAS replacement for fluorine-based polymer processing aids (PPA) to prevent shark skin appearance and die built up during film manufacturing and extrusion processes.

ACCUREL® PPA 2110 can be incorporated by using gravimetric dosing equipment. Alternatively, ACCUREL® PPA 2110 can be preblended with the virgin polymer.
