SIPERNAT® 22 is a precipitated silica, that combines a high absorption capacity together with a good flowability. It is our basic recommendation as a carrier silica for converting any kind of liquid into free flowing powders.

SIPERNAT® 22 is manufactured in accordance with HAC-CP-Guidelines following the Codex Alimentarius.

For the product made in Wesseling, Germany, a Feed Safety Quality Management Systems including Good Manufacturing Practice is implemented and certified by FAMI-QS, including the measurements according to Directive 2002/32/EU (undesirable substances). Furthermore, it is produced under the hygienic conditions of Regulation (EU) 852/2004 and the specification of the Regulation (EU) 231/2012 concerning food additives for silicon dioxide (E 551) is met.

STORAGE

Our silica products are inert and extremely stable chemically. However, due to their high specific surface area, they can absorb moisture and volatile organic compounds from the surrounding atmosphere. We therefore recommend storing the products in their original packaging (e.g. fully shrink-wrapped) or in sealed containers in a dry place away (or apart) from volatile organic substances. Even if a product is stored under these conditions, after a longer period it can still pick up ambient moisture over time, which could lead to its exceeding the specified moisture content. For this reason, our recommended use-by date is 24 months

after date of manufacture. Product more than 24 months old should be tested for moisture content before use in order to make certain that it is still suitable for the intended application.
